

General Advice:

Take proper precautions to ensure your own health and safety before attempting rescue and providing first aid. Seek medical advice if you feel unwell. Show this safety data sheet to the doctor in attendance.

Inhalation:

If inhaled, move person into fresh air and keep at rest in a position comfortable for breathing. Administer oxygen if breathing is difficult. Do not use mouth to mouth method if victim inhaled the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Give artificial respiration if victim is not breathing.

Skin Contact:

After handling, wash hands thoroughly with soap and water.

If on skin, remove/take off immediately all contaminated clothing. Rinse skin with water / shower. Wash contaminated clothing before reuse.

Eye Contact:

If in eyes: Rinse cautiously with water for 20 minutes. Remove contact lenses if present and easy to do. Continue rinsing. If irritation persists, seek medical advice.

Ingestion:

If Swallowed: Rinse mouth, Do NOT induce vomiting. If swallowed give 2-3 glasses of water if victim is conscious and alert. Do not give anything by mouth to an unconscious person. Seek medical advice immediately. Do not use mouth to mouth method if victim ingested the substance. Do not leave victim unattended. To prevent aspiration of swallowed product, lay victim on side with head lower than waist. Persons attending the victim should avoid direct contact with heavily contaminated clothing and vomitus. Wear impervious gloves while decontaminating skin and hair.

Section 5: Fire-Fighting Measures

Suitable Extinguishing Media:

Use extinguishing measures that are appropriate to local circumstances and the surrounding environment.

Specific Hazards Arising From the Chemical:

Not combustible. Under fire conditions, toxic, corrosive fumes are emitted. Do not allow run-off from fire fighting to enter drains or water courses.

Special Protective Actions for Fire Fighters:

Structural fire fighters' protective clothing provides limited protection in fire situations ONLY; it is not effective in spill situations where direct contact with the substance is possible. Wear chemical protective clothing that is specifically recommended by the manufacturer. It may provide little or no thermal protection. Wear positive pressure self-contained breathing apparatus (SCBA).

Section 6: Accidental Release Measures

Personal Precautions, Protective Equipment and Emergency Measures:

For personal protection, see section 8. Use personal protective equipment (e.g. gloves, boots) and ensure adequate ventilation. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing

Environmental Precautions:

Do not flush into surface or sanitary sewer system. If the product contaminates rivers, reservoirs or drains, inform respective authorities.

Methods and Materials for Containment and Cleaning Up:

Exercise caution during neutralization as considerable heat may be generated. Neutralize spill area with soda ash, sodium bicarbonate or lime. Flush neutralized spill with copious amounts of water.

Dike spill using absorbent or impervious materials such as earth, sand or clay.

Section 7: Handling and Storage

Precautions for Safe Handling:

For personal protection, see section 8. Avoid contact with eyes, skin and clothing. After handling, always wash hands thoroughly with soap and water. Do not get on skin or in eyes. Avoid breathing vapours and mists. Do not ingest. Handle and open container with care. Use only with adequate ventilation. Use caution when combining with water; DO NOT add water to corrosive liquid, ALWAYS add corrosive liquid to water while stirring to prevent release of heat, steam and fumes. This product reacts violently with bases liberating heat and causing spattering

Conditions for safe storage, including any incompatibilities:

Store in a cool/low temperature, well ventilated, dry place. Store locked up. Keep away from incompatible materials. Ventilate enclosed areas.

Directions for Use

- Rubber gloves and eyes protection should be worn. If chemical comes in contact with skin, wash immediately with soap and water.
- Test a small, inconspicuous area with a 24 hour waiting period to determine the suitability of product and if results are satisfactory before actual application.
- Pre-wet surface with water before applying Super Sparkle. Depending on the cleaning task, you may dilute by mixing with up to 20 parts of water. When diluting, always add acid cleaner to water and not water to acid.
- Apply Super Sparkle solution and allow it to sit 2-5 mins, agitate with stiff nylon or natural bristle brush or scrub pad to loosen haze, dirt or soil. Do not allow solution to dry on the surface.
- Use clean mop or cloth to remove the dirty solution. Rinse thoroughly with clean water to ensure removal of cleaning solution. If a sealer or impregnator coating is to be applied, neutralize the surface with a product such as Max D, Super Alka, followed by water, then allow the surface to thoroughly dry before applying.

Note:

- Super Sparkle should not be used on marble, terrazzo and other types of smooth polished surfaces.
- Product is incompatible with bleach or other chlorinated detergents, mixing with bleach will release poisonous chlorine gas present in bleach
- Surface may be damaged if Super Sparkle left on surface without rinsing or neutralisation
